SUBMISSION GUIDELINES

- **Through The Lens** is a **juried** exhibit and sale of fine art photography open to all photographers. Our juror is **Larry Winslett**, well-known Atlanta area nature photographer. www.larrywinslett.com/index.htm
- Each photographer may submit up to **four** photographs beginning July 1.
- All photographs must have been taken by the photographer submitting the entry form. Photographs must be original, not infringe on any copyright, and be suitable for family viewing. Photos submitted must be a reasonable expression of the theme. The idea is to create images that tell a story of the Southern Appalachians.
- **Submission for jurying** will consist of up to four prints, the entry form and fee in a manila envelope. Each print **must be 8"x10" or 8 1/2" x 11" and printed on photo paper.** Envelope must have photographer's name as well. Deadline for **receipt** of your submission is August 15. Include an SASE if you want your prints back.
- You will be notified during the week of August 22 as to which image(s) have been accepted. There is no guarantee any will be accepted.
- Images will be judged on technical quality, originality and expression of the theme.
- **Framed Photographs.** Each accepted photograph **must** be in a black professional quality frame with a white mat and must have hanging wire. Glass or professional Plexiglas must cover the print. Images not meeting these standards will be rejected. Photographer may also offer unframed prints.
- Each image must have the photographer's name, photo title, sale price and viewing orientation **on the back.**
- All work will be for sale. Artist retains all rights. SAA commission is 30%.

SUBMISSION GUIDELINES

(Cont)

- The maximum **matted** size must be no larger than 22" x 28" or equivalent square inches.
- Entries may be color or black and white, and may be shot on film or digital.
- The entry form must be filled out completely.
- **Entry Fee:** \$25 for SAA members and \$35 for non-SAA members. Check payable to SAA with entry form. Entry fees are non-refundable.
- Awards will be given for Best of Show, Places One through Three, Two Honorable Mention, Peoples' Choice and possible special awards.
